## **BOOTH FEE**

\$30 for each event date. Space size is approximately 11' x 11' or larger. Location of space will be provided a few days prior to the event via email. Fee is due upon application submission. Vendors will receive an email confirmation once a completed contract and fee is received. All events are non-refundable and non-transferable to another date. All dates are scheduled as a rain or shine event...no refunds and no transfers. Absolutely no refunds – no exceptions.

## VENDOR BEHAVIOR

It is expected that each vendor be respectful to each and every person on the property. Each person is to be treated with respect and dignity regardless of how they might treat you. Generations is a growing business and has a very positive relationship with the community and wishes to continue that way. Vendors having trouble with behavior or respectfulness shall be removed immediately.

## VENDOR ITEMS FOR SALE

Vendors will be categorized into 3 areas:

<u>Antiques/Vintage Collectible Vendor:</u> Appropriate items generally fall into the following categories: antiques, vintage, primitives, handmades, furniture (refinished, upcycled, repurposed, as is) and the like. No more than 25% of items are to be flea market/garage sale items.

<u>Flea Market Vendor:</u> Most of your items are normally available at a garage sale or flea market and not of a vintage/antique era. Note: This requires special permission to attend from Generations. Do not submit payment until approved.

Handmades (Craft / Art): All merchandise must be handcrafted. You are required to provide a picture of your merchandise with your completed application (via text or email). Only items types displayed, or the like, in the picture(s) will be permitted for sale unless you submit additional photos. Food packaging/handling must comply with food safety regulations.
